- The A&E department of this institute is located opposite PGIDS, Rohtak.
- Sr. Prof. I/C is working as head of A&E department.
- DMS is working as Administrative officer in the said department.
- CMO's are working here round the clock and are the officiating incharge of A&E deptt. during their working hours and they look after all the medico-legal work and administrative problems of the deptt. during their duties.
- All thermedical emergencies pertaining to Medicine, Chest & TB and Paeds deptt reach here and particular services are available as per rules in the concerned deptt. and patients are admitted as per rules in the concerned deptt.
- We are having a morchary chamber which can accommodate 6 (in number) dead bodies at a time which is situated on right hand of the entrance gate of A&E.
- There is a dispensary of emergency medicines in view of patients, in which all the emergency medicines are available round the clock and free of cost.

- Room no. 5 is reserved for VIP/doctors/staff patients.
- The A&E deptt is giving its emergency services to approx. 700-800 patients each day (per
- The staff on emergency duty i.e. doctors/nurses/bearers/sweepers/ security are available round the clock in three shifts and always ready to give their emergency services.
- In case of any disaster/mass casualty, we are having exter number of beds and special arrangements in Room no. 6 as well as in C-Block.

In view of above stated facts, the worthy Director is requested to give approval of the implementation of Proactive disclosure under section 4 of RTI act 2005.
