

7. M.Phil. in Psychiatry Social Work

ELIGIBILITY CONDITIONS

Educational Qualifications:-

I. B.Sc. Optometry:-

- a. A Candidate must have passed Sr. Sec. Certificate Exam. (10+2) of Board of School Education Haryana or equivalent exam with a minimum of 50% marks in the aggregate in the subjects of Physics, Chemistry, Biology and English taken together and passed the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations.
- b. In-service candidates (for B.Sc. Optometry) : (i) A person in regular employment shall also be eligible as in-service candidates provided he/she fulfils above qualifications for eligibility has passed the course of Ophthalmic Assistant/Optomety/Orthoptics (minimum 2 years duration) from any recognized Board/Council/University and thereafter is in regular employment with Haryana Health/Medical Education and research department and possesses a minimum experience of 3 years or more as Optometrist/Ophthalmic Assistant in Haryana Health/Medical Education and Research Department.
- c. If in-service departmental candidate is not available/not qualified then candidate having passed the course of Ophthalmic Assistant/Optomety/Orthoptics (minimum 2 years duration) from any recognized Board/Council/University with 3 years experience in any hospital/clinic shall be eligible against seats reserved for in-service candidates.

Further if the candidates of above categories are not available as given in para (b) & (c) above, the seat will be filled up by following Haryana Govt. reservation policy.

2. B.S.C. IN MEDICAL TECHNOLOGY OPERATION THEATRE (OT) COURSE :-

- a. A Candidate must have passed Sr. Sec. Certificate Exam. (10+2) of Board of School Education Haryana or equivalent exam with a minimum of 50% marks in the aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations.

Or

- ii. A person in regular employment of UHS/Haryana Health/Medical Education & Research Department who applies through proper Channel must have passed [Sr. Sec. Certificate Exam. (10+2) of Board of School Education Haryana/Pre -Medical or equivalent exam with a minimum of 50% marks in aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations. And she/he possesses a Diploma in Operation Theatre Technician from an Institution/Board Council recognized by Haryana Govt. and has a minimum of 3 years of experiences as O.T. Assistant/O.T. master in various capacities in Haryana Govt. under Medical Education & Research Department. If in-service candidates with above mentioned criteria are not available/not qualified then.
- (ii) A person in regular employment of UHS/Haryana Health/Medical Education & Research Deptt. who applied through proper channel having passed Matric Exam. (10th class) of Board

of School Education Haryana or equivalent exam with a minimum of 50% marks in aggregate with Hindi and English taken together in case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations. And she/he possesses a Diploma in Operation Theatre technician from an Institution/Board Council recognized by Haryana Govt. and has a minimum of 5 years of experience as O.T. Assistant/O.T. master in various capacities in Haryana Govt. under Medical Education & Research Department. If in-service candidates with above mentioned criteria are also not available/not qualified then.

- (iii) A person in regular employment of UHS/Haryana Health/Medical Education & Research Deptt. who applies through proper channel must have passed Sr. Sec. Certificate exam (10+2) of Board of School Education Haryana/Pre-Medical or equivalent exam with a minimum of 50% marks in aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examinations. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations. And she/he possesses a minimum of 5 years of experience in Operation theatre in various capacities in Haryana Govt. under Medical Education & Research Deptt.

3. **B.SC. MEDICAL LAB. TECHNOLOGY (B.SC. MLT):-**

Candidate must have passed Sr. Sec. Certificate Exam, (10+2) of Board of School Education Haryana or equivalent exam with a minimum of 50% marks in the aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations.

FOR IN-SERVICE CANDIDATES APPLYING THROUGH PROPER CHANNEL:-

Those employees who have put in a minimum 5 years of regular service even after passing Diploma in MLT from the Institution/Board/Council recognised by Haryana Govt.

4. **B.SC. IN RADIOTHERAPY TECHNOLOGY:-**

Candidate must have passed Sr. Sec. Certificate Exam, (10+2) of Board of School Education Haryana or equivalent exam with a minimum of 50% marks in the aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations.

5. **B.SC. IN RADIOGRAPHY & IMAGING TECHNOLOGY:-**

Candidate must have passed Sr. Sec. Certificate Exam, (10+2) of Board of School Education Haryana or equivalent exam with a minimum of 50% marks in the aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations.

6. **B.SC. IN PERFUSION TECHNOLOGY:-**

Candidate must have passed Sr. Sec. Certificate Exam, (10+2) of Board of School Education Haryana or equivalent exam with a minimum of 50% marks in the aggregate in the subjects of Physics, Chemistry, Biology and English taken together and pass the qualifying examination. In case of SC/ST/BC candidates the marks obtained should be read as 40% in qualifying examinations.

Note:- To determine the minimum eligibility criteria, calculation of marks obtained in qualifying examinations will be made as per instructions of the Chief Secretary to Govt. of Haryana bearing No.22/129/2013-IGS III dated 16.07.2014.

- Admission to above courses will be made on the basis of the merit of Common entrance test.
- The list of the examinations recognized as Equivalent to 10+2 examinations Board of School Education Haryana is available in the Academic Branch, Pt. B.D. Sharma University of Health Sciences, Rohtak.



6.	B.Sc. in Perfusion Technology	Three academic years. followed by six months compulsory internship training.

5. NOC from Parent college
6. The candidate should deposit a fee of Rs. 50000/- .

MIGRATION

If seat is vacant in present batch than only migration is considered.

The following document are required for Migration (1st Prof to 2nd Prof.).

1. NOC from Parent College
2. Compassionate ground criteria:-
 - d) Death of a supporting guardian
 - e) Illness of the candidate causing disability
 - f) Disturbed conditions as declared by Government in the Medical College Area etc.
3. The applicant candidate should have passed first professional MBBS examination.
4. The applicant candidate submits his application for migration, complete in all respects to all authorities concerned within a period of one month of passing (declaration of result) the first professional MBBS Examination.
5. The candidate must submit an affidavit stating that he/she will pursue 18 months of prescribed study before appearing at 2nd prof. MBBS examination at the transferee medical college, which should be duly certified by the Registrar of the concerned University in which he/she is seeking transfer. The transfer will be applicable only after receipt of the affidavit.
 - Stipend for Internship = Rs.17000/- in house candidates
 - Period of internship one year
