This is in reference to Minutes of the Meeting circulated vide letter No. SPIO/PGIMS/2022/3713-34 dated 06.06.2022 regarding implementation of pro-active disclosure under Section-4 of RTI Act 2005. The detail related to Gas Manifold Section, PGIMS, Rohtak to be disclosed under Section-04 of the RTI act is as under:-

1. The Deputy Medical Superintendent is the PIO of Gas Manifold Section, PGIMS, Rohtak
2. The Gas Manifold Section is located on Ground Floor, Main Hospital. In addition the Mother & Child Hospital, Dhanwantri Apex Trauma Centre and LSL Building ('A' Block) & New OT-cum-ICU Complex have their own Gas Manifold Rooms.
3. At present twelve regular Gas Room Operators, one Clerk and two Group-D employees are posted in Gas Manifold Section.
4. The Gas Manifolds are working round the clock in three shifts and deals with essential medical gases.
